What to do if you fall pregnant

1. The Integrated Service Centre for Migrant Women and Children offers assistance. Call 03-2522522
2. You can keep working when pregnant.
3. The foreign worker and employer can agree to a termination of their labor contract.
4. Holders of National Health cards are eligible to receive prenatal check ups and health education guidance at local medical facilities.
5. When a legal foreign worker gives birth in Taiwan she can apply for legal residency status on behalf of the child.
6. Foreign workers can apply for the suspension of an employer transfer when pregnant.

雇主如歧視或任意解僱懷孕產子的移工，而有違反性別工作平等法等相關規定，將依法處罰

移工孕婦可以請產假嗎？

移工適用性別工作平等法，懷孕期間所有假期皆同本國籍勞工

Q

移工可以終止聘僱轉換雇主嗎？

勞雇雙方合意終止聘僱關係並經勞動部廢止聘僱許可，移工可以轉換雇主或工作。

因不可歸責於雇主，原雇主可以引進或聘僱新移工，另製造業雇主聘僱外國人總人數，可不計入懷孕人數。
